TERMS AND CONDITIONS FOR ALL SERVICES BY ROWAN PACIFIC RIM DECORATORS TO LESSEES/CUSTOMERS

1. This lease/contract comprises the entire lease/contract between Rowan Pacific Rim Decorators, Inc. (hereafter referred to as the Company) and the LESSEE/CUSTOMER. It is acknowledged that there are no understandings, representations, warranties, promises, verbal or otherwise, pertaining to this lease/contract or to the equipment, which are not incorporated herein expressly by reference or rider attached hereto.
2. Company shall have the right without notice to terminate this contract in the event of breach of any of its terms, conditions or promises.
3. We suggest that you arrange all-risk insurance coverage on your exhibits and materials, as Rowan limits its liability to \$5.00 per article, with a maximum of \$50.00 per each claim situation.
4. TERMS: Please refer to the "Payment Policy" paragraph on the first page of this kit. Unless otherwise arranged through Rowan Pacific Rim Decorators, all prices are net upon presentation.
5. UNPAID BALANCES- For those with credit extended: terms will be net, due and payable upon receipt of invoice. Effective 30 days after invoice date, any unpaid balance will bear a FINANCE CHARGE at the lesser of the maximum rate allowed by applicable law, or 1.5% per month, which is an ANNUAL PERCENTAGE RATE of 18%. If any finance charge hereunder exceeds the maximum rate allowed by applicable law, the finance charge shall automatically be reduced to the maximum rate allowed, and any excess finance charge received by ROWAN PACIFIC RIM DECORATORS shall be either applied to reduce the principle unpaid balance or refunded to the exhibitor. This Payment Policy agreement shall be governed by and construed in accordance with the LAWS OF THE STATE OF ALASKA.
6. The person signing this order or an order form at an event for the customer, guarantees payment of the account personally.
7. All charges are earned upon performance by the Company, regardless of subsequent events.
8. The said equipment shall at all times remain and be the sole and exclusive property of the Company and the LESSEE shall have only the right to use it under the conditions here contained. The leased equipment shall not be transferred, leased, used or subject to any person other than the LESSEE. This lease shall not be assigned by LESSEE by his own act or by the operation of law. The equipment will not be removed from said premises and will not be used at any other place or for any other purpose except that stipulated.
9. The LESSEE shall at all times and at his own expense keep the leased equipment in good, safe and efficient working order, repair and condition and shall not permit anyone to injure, deface, or remove it or any part thereof.

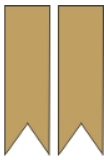
WHAT DO I NEED TO FILL OUT FOR YOU REGARDING MY SHIPMENT?

The following worksheet helps us to track your freight from the point where you ship from until it arrives. It also helps you in calculating your costs. Things may change between the time you send this back and the time you actually ship. That is ok, you can update by email, (just let us know if tracking #'s change), or amount of items shipped changes. We will email you when your load gets here, and what it weighed.

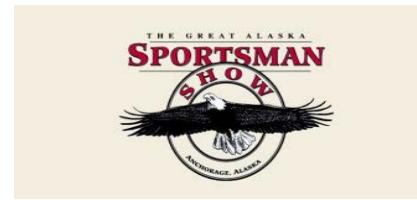
Multiple loads which arrive at the warehouse on different days are regarded as separate shipments and start the “1-200 lb.” calculation all over again. That is to encourage shippers to consolidate their loads, and allows us better control when it all comes in at once. Should your shipper “forget” to get a package off the truck or leave one behind, no worries- Rowan will NOT charge you in case of that happening.

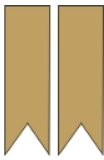

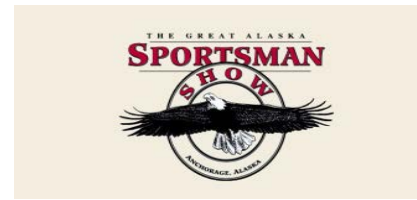
